The topic of the webinar will be the discussion of the relief for new investments, which was changed on January 1, 2022. During the meeting, a new map of assistance and the criteria for applying for the relief will be presented. In addition, practical issues that have emerged recently along with the presentation of individual interpretations and court judgments on selected issues will be discussed.

- a) Amendments to the regulation on state aid,

- a) Individual interpretations,
- b) Judgments of administrative courts and the Supreme Administrative Court.
